- 2) Los Angeles Convention Center (LACC)
  - a. January 21, 2011 report requesting write-off of 19 uncollectible accounts receivable totaling \$7,355.64 representing invoice amounts less than \$5,000.00.

**ACTION:** The Board unanimously approves the request from the LACC to remove from its active accounts receivable the uncollectible amount of \$7,355.64 representing 19 accounts less than \$5,000.00.

b. January 21, 2011 report requesting write-off of one (1) uncollectible account receivable totaling \$12,678.85 representing invoice amounts equal to or more than \$5,000.00.

**ACTION:** The Board unanimously recommends that the City Council approve the write-off request from the LACC to remove from its active accounts receivable, one account totaling \$12,678.85.

#### 3) City Planning Department

March 31, 2011 report requesting write-off of 34 uncollectible accounts receivable totaling 28,415.52 representing invoice amounts less than \$5,000.00.

**ACTION:** The Board unanimously approved the request from City Planning to remove from its active accounts receivable the uncollectible amount of \$28,415.52 representing 34 accounts less than \$5,000.00.

### 4) Department of Building and Safety (LADBS)

February 28, 2011 report requesting write-off of 2,031 uncollectible accounts receivable totaling \$291,395.18 representing invoice amounts less than \$5,000.00.

## 5) Public Works – Bureau of Sanitation (LABPW)

April 8, 2011 report requesting write-off of 1,298 uncollectible accounts receivable totaling \$165,997.81 representing invoice amounts less than \$5,000.00.

**ACTION:** The Board unanimously approved the request from LABPW to remove from its active accounts receivable the amount of \$165,997.81 representing 1,298 accounts less than \$5,000.00 per account.

a. March 14, 2011 report requesting write-off of 27 uncollectible accounts receivable totaling \$207,847.40 representing invoice amounts equal to \$5,000.00 or more.

b. March 14, 2011 report requesting write-off of 3,154 uncollectible accounts receivable totaling \$3,193,654.47 representing invoice amounts less than \$5,000.00.

**ACTION:** The Board unanimously approved the request from the LABPW to remove from its active accounts receivable the uncollectible amount of \$3,193,654.47 representing 3,154 accounts less than \$5,000.00 per account.
