1) Approval of the Minutes of January 27, 2021

The Board unanimously approved the January 27, 2021 minutes.

2) Los Angeles Housing + Community Investment Department (HCIDLA)

March 30, 2021 report requesting the write-off of 61 uncollectible invoices for 11 owners of 24 property (APNs) accounts with fees totaling \$97,124.71, each owner owing more than \$5,000.00.

ACTION: The Board unanimously recommends that City Council approve the write-off request from HCIDLA to remove from its active account receivables, 61 uncollectible invoices (11 owners, 24 APNs) for fees totaling \$97,124.71.

March 30, 2021 report requesting the write-off of 1,855 uncollectible invoices for 1,151 owners of 1,183 property (APNs) accounts with fees totaling \$1,026,431.23, each owner owing less than \$5,000.00.

ACTION: The Board unanimously approve the write-off request from HCIDLA to remove from its active account receivables, 1,855 uncollectible invoices (1,151 owners, 1,183 APNs) for fees totaling \$1,026,431.23.

3) Los Angeles Department of Transportation (LADOT)

March 30, 2021 report requesting the write-off of 344,746 citations (185,785 plate holder accounts) with fees totaling \$46,014,243.65, each unique plate owner owing less than \$5,000.00.

ACTION: The Board unanimously approve the write-off request from LADOT to remove from its active accounts 344,746 uncollectable citations (185,785 plate holder accounts) for fees totaling \$46,014,243.65.
